MEMBER NOTIFICATIONS

<u>Regulation CC/Funds Availability Change Notice</u>

Effective July 1st, 2025, the Funds Availability Notice found in the Membership Agreement and processing of check holds at H.P.C. Credit Union ('Credit Union') has been updated to follow regulatory guidelines. For qualifying check holds, the first \$275 of the deposit will be released on the first business day after the day of deposit. Additionally, if the qualifying check deposit totals \$6,725 or more, the first \$6,725 may be released on the third business day after the date of deposit; and funds in excess of the first \$6,725 will be released on the ninth business day after the date of deposit. More information describing these changes can be found in the Change In Terms Notice to H.P.C. Credit Union Members.

IRA Dividend Payment Notice

Effective July 1st, 2025, dividends earned from Traditional IRA Share, Roth IRA Share, and Coverdell IRA will be compounded monthly and paid monthly instead of quarterly. This change from quarterly to monthly was made to be consistent with Traditional IRA Special Premier Share and Roth IRA Special Premier Share. Information regarding savings products offered by H.P.C.
